Invisible Check Program

We are pleased to offer our members an automated clearinghouse program (ACH) as a value-added service.

Our automated clearinghouse program enables your REMC payment to be electronically transferred from your financial institution to Jasper County REMC's account each month. The electronic transfer of funds from your checking or savings account will take place each month on the due date of the electric bill.

You will continue to receive your monthly bill that includes information about kilowatt usage, meter read dates, account and location information. The bill will also include a statement that the amount due will be electronically transferred from your account to the REMC account.
